Introduction

The Streetside Activation Grant Program offers up to \$5,000 to small businesses, organisations and property owners for a variety of street-level activation ideas. These grants have been jointly funded by the City of Adelaide and State Government to reignite the City.

The grants provide direct support to existing businesses in the City and North Adelaide to activate nearby footpaths, streets and park lands by bringing their business offerings (existing or new) outdoors in a covid-safe manner, or to attract people to their business / location in a new way.

Applicants are encouraged to submit ideas that activate outdoor areas in front of the business or organisation through the temporary activations or infrastructure.
